WATER EQUIPMENT USE AGREEMENT

This Agreement is entered into between the City of Seligman and the customer designated herein.

Customer shall hereinafter refer to: _____,

Property shall hereinafter refer to: (address or parcel) _____, Seligman, Missouri.

Whereas, the Customer desires to purchase water from the City and to enter into an agreement for the installation, service and use of a water meter, meter box and water equipment incidental thereto belonging to the City of Seligman, which shall hereinafter be referred to as water equipment.

It is therefore agreed, in consideration for payment set forth herein and all mutual covenants, promises and agreements, the parties agree as follows:

The City of Seligman shall furnish, subject to the ordinances of the City of Seligman now in effect as of the signing of this agreement or as passed hereinafter, such quantity of water as the customer may desire in connection with customer's occupancy of the property.

The customer shall install and maintain at customer's expense a service line, which shall begin at the meter and extend to the dwelling or place of use. The service line shall connect with the distribution system of the City of Seligman at the nearest place as determined by the City of Seligman.

The customer agrees to comply with and be bound by ordinances, rules and regulations of the City of Seligman in force or as hereinafter duly and legally supplemented, amended, created or changed.

The customer agrees to pay all tap fees, equipment fees and utility billing deposits associated with the installation of services requested and required by ordinance. In the event service to the customer is terminated, either voluntarily by the customer or by the City of Seligman for any reason, the deposit shall be held and applied by the City of Seligman to any unpaid balance then owing on the customer's account. Should the account be fully paid at the time of the termination of service to the customer, the deposit shall be refunded to customer within a reasonable time.

The City of Seligman shall purchase and install water equipment in each service. The City of Seligman shall have exclusive right to use the water equipment. It is recommended the customer purchase any additional devices necessary to ensure proper service to the property including but not limited to a cut off valve between the water equipment and the property serviced so long as the water equipment of the City of Seligman is at no time tampered with, altered, modified or damaged.

Customer shall not tamper with, alter, modify or damage the water equipment. In the event customer breaches this agreement by tampering with, altering, modifying or damaging the water equipment, customer agrees to immediately pay to the City of Seligman the sum of any repairs for the water equipment.

Customer grants an irrevocable right to the City of Seligman for ingress and egress upon the property to provide service to, maintain and remove the water equipment owned by the City of Seligman at any time.

In the event customer breaches this agreement and the City of Seligman must enforce this agreement, customer shall pay all of the costs of collection, attorney fees and court costs incurred by the City of Seligman.

This agreement is binding on the parties, their heirs, assigns and personal representatives.

The laws of the State of Missouri shall govern this contract and any disagreements concerning this contract shall be litigated in the Barry County Circuit Court in the appropriate division.
